#### **DOG PLAY ARENA RULES**

1. Dogs may be off leash only within the designated fenced area.
2. Owners/Handlers must clean up after their dogs.
3. Dogs must have current vaccinations (DHLPP and Rabies).
4. Aggressive dogs are not allowed. The owner/handler of any dog(s) exhibiting aggressive behavior are required to immediately remove the offending animal.
5. Pit Bulls are prohibited.
6. An adult must accompany children less than 14.
7. Female dogs in season are not allowed at the facility.
8. Agility equipment is for dogs only.
9. If vaccines are expired your membership will be suspended.
